

Wave 14: Module summary

Wave 14 contains 34 updated modules, 5 of which are new (National Citizen Service, Work illness, Generalised trust, Non-residential identifier and Non-residential children). For the pre-existing modules, a number of data collection enhancements have also been developed (see the table below for details).

New entrants and W14 Boost sample:

For new entrants to the survey, particularly with the Wave 14 Boost sample (GPS2), several modules were expanded to understand background and families. These include additional questions about dates of the first job, partnership histories, reasons for migration, parents' educational background, parents' national identity and English as a first language.

Whole sample:

New sets of questions are included to identify and collect information on non-resident children, including biological, adopted, and step-children. Information is collected in several modules including **Family Networks, Non-resident identifier, Non-resident children, Non-co-resident relationships and for those new to the Study, in the module Fertility History.**

The working paper [Improving questionnaire content for parents and families living apart](#) explains the changes made to questionnaire content in waves 14 and 15 to improve the identification of parents living apart and the data we provide about families across households.

The [long-term content plan](#) lists the Waves in which all the modules were last asked and when they will be asked again. This table lists the modules in the order they are asked within the Wave 14 questionnaire.

Please note:

Soft checks are used to double check an answer. The respondent can proceed through the questionnaire without changing their answer e.g. You have said you have 15 mortgages?

Hard checks are used to double check an answer but the respondent cannot proceed through the questionnaire without editing their response e.g. The date you moved address is set in the future.

Rotating Modules do not always carry every question at each rotation. Use the [Variable Search](#) tool to establish in which Waves the variables appear.

Consent questions are mostly asked every 3 years to those who have not already consented to data linkage e.g. new entrants, 16+ year olds previously given consent by their parents and those who have previously refused consent less than twice before.

The column 'Changes in questions (variables) or responses' in the table below provides a detailed list of modifications within each module. We have not distinguished between minor and major changes, to see the exact change, please take a look at the [questionnaires](#).
